Purpose

This report is intended to document the state requirements regarding the delivery of instruction at ICS. This monthly report will be presented to the ICS Board of Education every 30 days after approval of the Extended COVID-19 Plan and will be posted to the transparency link of the district website. This report meets all legislative requirements and includes additional, recommended disaggregation of data.*

Statute

Sec. 98a(1)(c) Thirty days after the approval of the plan under subsection (2), and every 30 days thereafter, the district must, at a meeting of the board or board of directors, as applicable, of the district, re-confirm how instruction is going to be delivered during the 2020-2021 school year. Public comment must be solicited from the parents or legal guardians of the pupils enrolled in the district during a meeting described in this subdivision.

Sec. 98a(1)(i) The district shall publicly announce its weekly interaction rates under this subdivision at each reconfirmation meeting described in subdivision (c) and make those rates accessible through the transparency reporting link located on the district's website each month.

OCTOBER Reconfirmation

Reconfirm how instruction (Return to Learn Plan) is going to be delivered during the 20/21 school year: (Recommendation: Explain in narrative form any modifications to the original Extended Learning Plan)

Based on attendance/engagement rates and the results of parent surveys and feedback, I am recommending that the ICS Board of Education reconfirm the ICS Return to Learn Plan adopted last month without modification.

Document Public Comments: During this four-week cycle, an online interactive Zoom meeting was held for all parents of elementary remote learning and virtual students. We discussed program options, the declaration date for returning to face-to-face instruction, the next program review date, and the subsequent survey regarding remote and virtual learning for parents. No program changes are required at this time per the survey and enrollment shifts.
